UNIVERSITI PUTRA MALAYSIA (ACADEMIC MATTERS FOR UNDERGRADUATES) (AMENDMENT) RULES 2016

A Rules to amend Universiti Putra Malaysia (Academic Matters For Undergraduates) 2014.

IN EXERCISE of the power conferred by section 37(1) of the Constitution of Universiti Putra Malaysia, the Board of Directors makes the following Rules:

Short Titles, Application and Date of Commencement

1. These Rules may be cited as Universiti Putra Malaysia (Academic Matters For Undergraduates) (Amendment) 2016 and shall come into force on 1st September 2016.

Interpretation

2. In these Rules, unless the context otherwise requires-

"Parent Rules" means Universiti Putra Malaysia (Academic Matters for Undergraduates) Rules 2014.

Amendment to the Parent Rules

- 3. The Parent Rules are amended as follows:-
 - (a) by substituting the entire paragraph of "equivalent course" in Rule 2 of the Parent Rules with the following paragraph:-

""equivalent course" means a course of studies identified by Faculty as equivalent with other course of studies by taking into account that the said course of studies has similar contents and teaching hours with the other course of studies according to the percentage of similarity prescribed by the Agency charged with the responsibility of quality assurance and accreditation of the Malaysian higher education, and the Ministry charged with the responsibility of the Malaysian higher education, as decided by the Senate, from time to time";

(b) by inserting after Rules 51 of the Parent Rules, Rules 51A as follows:-

"Conducting University Proficiency Course by Other Entity in the University

- 51A (1) The Senate may, from time to time, direct any other entity within the University, other than the main University academic entities, to conduct or manage any proficiency courses to enhance the competency and skills of students.
- (2) The provisions of Part E, F, G, H and J in these Rules, shall apply *mutatis mutandis* for directions of the Senate under subrule 51A(1)."
- (c) by inserting after subrule 60(2) of the Parent Rules, subrule (3) as follows:-
 - "(3) Senate may from time to time amend the Sixth Schedule."
- (d) by substituting the phrase "...under rule 19 and 59 of this Rules", with the phrase "...under rule 19 and 58 of this Rules," in Rule 76 of the Parent Rules.

- (e) by substituting the phrase "...Office of Bursar" with the phrase "...office charged with the financial responsibility of the University" in Rule 79(1) of the Parent Rules.
- (f) in the National Language text, by substituting the phrase "(Rule 61 and 62(k))" in the title in the Sixth Schedule of the Parent Rules, with the phrase "(Rule 60 and 61(k))."
